

NOTICE OF APPEAL

Agua Pina, LLC d/b/a Hookah on the River (“Respondent”) appeals the Final Order and Decision of the Honorable Ralph King Anderson, III filed June 28, 2021 and Order on Reconsideration filed July 22, 2021 denying Respondent’s Motion for Reconsideration, which have the effect of revoking Respondent’s on-premises beer and wine permit and liquor-by-the-drink license for its location at 2700 Broad River Road, Suite B, Columbia, South Carolina. A copy of the Orders are attached hereto as Exhibits A and B, respectively. Respondent received written notice of entry of the Final Order on June 28, 2021. Thereafter, on July 7, 2021, Respondent filed a Motion for Reconsideration with the Administrative Law Court. Judge Anderson denied that Motion on July 22, 2021, and Respondent received the Order on Reconsideration on July 22, 2021. Thus, pursuant to Rule 203 of the South Carolina Appellate Court Rules, this Notice of Appeal is timely filed within 30 days of receipt of that Order.

Since receiving the Order, the Respondent has requested and received the hearing transcript. Therefore, the deadline for filing the Initial Brief with this Court is Thursday, September 16, 2021.




