So I'm need extension of time. I requested legal envelopes on the tablet going to kiosk, and ~~it had been~~ they responded and said they will get the legal envelopes for me. But I haven't received ~~as of~~ yet. Please grant me at least 30 days. Please check and see if your office has received the record on appeal and proof of service that I had my family make a copy of. I just put record on appeal for the heading of my initial Brief. I can't even send the Respondent, SC Attorney General's office proof of service and a copy of this request for an extension of time, because I don't have a legal envelope. There has been interference with us going to canteen, being talked in our cell being quarantined. Q3B has not been to canteen since placed on quarantine.
