

Enclosed for filing is a Notice of Appeal in the above case. Also enclosed are the following:

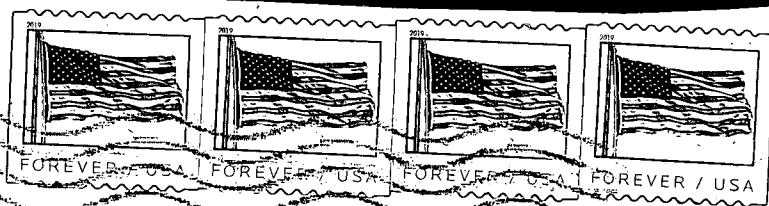
- (1) Proof of Service of the Notice of Appeal on the Respondent, and the Acceptance of Service by the Respondent of the same.
