

NOTICE OF APPEAL

ANTAVIUS D'ARGO HILL appeals his sentence imposed by the Honorable Daniel D. Hall on August 19, 2021. He pled to 2<sup>nd</sup> Degree Burglary and Possession of Ecstasy 1<sup>st</sup> offense, under NC vs. Alford. He was sentenced to eight (8) years in the SCDC, suspended on the service of 40 months and three (3) years' probation, with credit for time served ( 522 days) on the Burglary 2<sup>nd</sup> Degree charge. Mr. Hill was sentenced to time served for the Possession of Ecstasy 1<sup>st</sup> offense charge. He was also ordered to pay court costs and fees.





He was sentenced by the Honorable Daniel D. Hall.



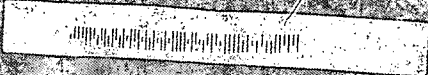
