Ms. Harrison:

Trial counsel Jason King called me and informed me that Mr. Robinson is appealing the denial of his motion to relieve Mr. King as his counsel dated August 13, 2021. I have attached a copy of that order that was requested in the deficiency letter. This order appears to be interlocutory.
