Although the order is dated August 4, 2021, I the petitioner didnt receive it until August 16, 2021. Thwarted me from timely filing a motion to reconsider. The Warden Mr Nelson, my

dorm Lt. Mr Shuler and dorm Sgt Mr Martin can verify and will inform the Courts of me complaining. At times the mail room was outright closed conducting NO business. I wrote requests as far as on the automated Kiosk system to verify hardships I endured. These above named prison officials informed me to ~~they~~ tell the Honorable Courts and they would verify. But I the petitioner complied to ALL court rules, but issues with the mailroom hindered my efforts. This is my fourth PCR and each time an issue with my mail not being properly distributed or received has been the issue that caused my loss. I throw myself at the mercy of the Courts for help.

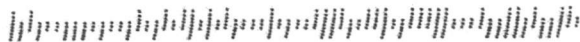
