(1) A COPY OF THE ORDER ISSUED IN CASE 2021-000629 WHICH IS THE SISTER CASE OF CASES 2020-0001667; 2020-000974 AND 2020-0001615. THE ORDER IN THOSE CASES IS DATED AUGUST 6, 2021. THE UNITED STATES SUPREME COURT ALREADY HAS A COPY OF THE FINAL ORDER FROM THOSE CASES PREVIOUSLY SENT BY THE PETITIONERS.

THESE ARE SISTER CASES, ESSENTIALLY IDENTICAL CASES, THAT WERE SOUGHT CONSOLIDATED BEFORE THE SOUTH CAROLINA SUPREME COURT. 


