PETITION FOR THE COURT TO SET AN APPEAL BOND

Pursuant to Rule 246(a), SCACR and S.C. Code Ann. §§ 18-1-80 and 90, Charles Dent respectfully petitions this Court to set an appeal bond.

PROCEDURAL HISTORY

On or about September 14, 2014, the State of South Carolina charged Mr. Dent with two counts of first-degree criminal sexual conduct with a minor and two counts of disseminating obscene material to a minor. Exhibit A.

On or about September 18, 2014, the Court of General Sessions for Beaufort County set bond on these charges totaling \$130,000.00 dollars with special conditions including home detention at his home in Alabama, a restraining order, and electronic monitoring. Mr. Dent posted bond. Exhibit A.

From May 4-8, 2018, the Court of General Sessions for Beaufort County tried Mr. Dent before a jury for these charges. Mr. Dent appeared for his trial, and the trial court

allowed him to remain on bond through the duration of the trial. On May 8, 2018, the jurors found Mr. Dent not guilty of one count of first-degree criminal sexual conduct with a minor. The jurors found Mr. Dent guilty of one count of first-degree criminal sexual conduct with a minor and both counts of disseminating obscene material to a minor. R. 9-12. The trial court sentenced Mr. Dent to concurrent terms of imprisonment of thirty years for first-degree criminal sexual conduct with a minor and fifteen years for each count of disseminating obscene material to a minor twelve years or younger. R. 13-15.

Mr. Dent appealed to this Court. On August 18, 2021, this Court issued a written opinion reversing Mr. Dent's convictions and sentences because the trial court erred by not providing the jury instruction required by *State v. Logan*, 405 S.C. 83, 747 S.E.2d 444 (2013) and *State v. Herndon*, 430 S.C. 367, 845 S.E.2d 499 (2020). On August 26, 2021, the State petitioned for rehearing. On September 2, 2021, Mr. Dent petitioned for rehearing, asking this Court to decide the remaining issues raised by his appeal.

STANDARD OF REVIEW

Rule 246(a), SCACR provides, “[A] sentence of confinement shall not be stayed until the defendant has posted bail under S.C. Code Ann. 18-1-80 and 90 (1985). Where the sentence exceeds imprisonment for ten (10) years, the defendant may only be admitted to bail by an appellate court.” With the petitions for rehearing pending, this Court has jurisdiction to hear this petition. *In re Michael H.*, 360 S.C. 540, 552, 602 S.E.2d 729, 735 (2004) (Rule 221(b), SCACR “provides that the Court of Appeals retains jurisdiction until [the Supreme Court] grants or denies a petition for *certiorari*”). “The factors to be considered in admitting a person to bail pending appeal include the probability of reversal,

the nature of the crime, the possibility of escape, and the character and circumstances of the appellant.” *Id.*, 360 S.C. at 553, 602 S.E.2d at 736.

DISCUSSION

Mr. Dent does not dispute the serious nature of the State’s allegations against him; however, he respectfully believes the other three factors set forth in *In re Michael H.* militate in favor of releasing him on an appeal bond. First, the State and this Court unanimously agreed the trial court erred by not providing the jury instruction required by *Logan* and *Herndon*. Although the State and dissent believe the error to be harmless, Mr. Dent respectfully believes he will ultimately be successful on this issue. Second, there is no danger Mr. Dent will escape or flee if released on bond. The best predictor of future conduct is past conduct. For almost four years prior to his jury trial, Mr. Dent remained out of custody on bond, and he appeared for his trial. As will be discussed below, this Court can set appropriate conditions of bond to ensure Mr. Dent’s appearance. Third, Mr. Dent’s character and circumstances support his release on bond. Mr. Dent is a twenty-year veteran of the United States Navy, where he had a security clearance and was an instructor for anti-terrorism training. R. 616-17. Mr. Dent does not have a prior criminal history. R. 785.

Mr. Dent also has a support network that will provide stability if this Court allows him to be released on bond. His brother, David Dent, lives Troutman, North Carolina. David Dent is willing for his brother to live at his home in North Carolina. *See* Affidavit of David Dent (Exhibit B). Mr. Dent’s family and friends believe it makes more sense for him to live in South Carolina until this legal matter is resolved. Mr. Dent’s longtime friends, Mitch Fife and Terri Fife, are willing to allow Mr. Dent at their home in

Summerville, South Carolina. *See* Affidavits of Mitch Fife (Exhibit C) and Terri Fife (Exhibit D).

Mr. Dent is a disabled veteran. Even prior to his May 2018 jury trial, Mr. Dent's health was very poor, and he required care at the VA Hospital. Within a few days of entering the South Carolina Department of Corrections, Mr. Dent had a heart attack and required outside medical treatment. Throughout most of his incarceration, the Department of Correction has housed Charles at the Kirkland Reception & Evaluation Center so that he would receive better medical treatment. Charles will need routine medical and dental care that he can get at the VA hospital. Exhibits B, C, & D; *see also* SCDC Inmate Search Detailed Report (Exhibit E). This report also states Mr. Dent has not had any disciplinaries during his incarceration.

David Dent, Mitch File, and Terri Fife will be able to ensure Mr. Dent has transportation to medical appointments, legal appointments, and court dates. They also agree to report to the Court if Mr. Dent violates the conditions of his bond. Exhibits B, C, & D.

Also, Mr. Dent's mother, who lives in the Charlotte, North Carolina area, is 86 years old and in failing health. Therefore, Mr. Dent would respectfully request any bond conditions allow him to travel to North Carolina to visit his mother. *See* Exhibit B.

CONCLUSION

For the foregoing reasons, Charles Dent respectfully requests this Court set an appeal bond.
