The Petition for Writ of Certiorari to the South Carolina Court of Appeals in the Supreme Court of South Carolina, and Appendix in this matter, is due for service and filing on September 2, 2021. Undersigned counsel lives in Louisiana and was directly affected by Hurricane Ida on August 29, 2021. Hurricane Ida made landfall in Louisiana as a Category 4.
