COUNT ONE-MURDER

That MICHAEL CHRISTIAN BARCLAY, JIMMY LEE HAMPTON, JR AND DEMONTA KABORA HICKSON did in Florence County, on or about August 25, 2018, willfully, feloniously, and intentionally kill the victim, [REDACTED] with malice aforethought, when they drove by [REDACTED] South Carolina in Florence County searching for [REDACTED] and opened fire on the house either express or implied, by means of shooting, and the victim did die as a proximate result thereof on or about August 25, 2018 in Florence County, in violation of Section 16-03-0010, S.
