1. Due to limited capacity in Courtroom II, only one lawyer per party making argument in the case will be permitted to attend oral argument. 2. Face coverings are required at all times while in the Courthouse. You may remove your mask only when at the podium making arguments before the Court.
3. Please maintain social distancing, defined as keeping a distance of at least 6 feet from others, at all times while in the Courthouse.
4. Counsel will be asked to sit in assigned spots. Please stay in your seat until you are called to argue. We understand the need to exchange pleasantries, but ask that you keep your seat and remain masked when speaking with others.
5. Hand sanitizer is available in the courtroom, and we ask that counsel use it liberally as you enter or leave the courtroom and/or restrooms.
6. If you arrive before the argument before yours has ended, please wait in the hallway until your case is called, while maintaining social distance. Upon conclusion of your argument, please exit the Courthouse as expeditiously as possible. Do not gather to talk until you have left the building.
