PLEASE TAKE NOTICE that the Appellant hereby moves the Court of Appeals for an extension of time to serve the Record on Appeal in the above-referenced matter. The deadline for service of the Record on Appeal is due on September 15, 2021, and Appellant seeks an extension of seven days until September 22, 2021.
