① Your use of State v. Devore, 416 SC 115, 119, 784 SE 2d 690, 692 (Ct. App. 2016) Rule 203 (b)(2), SCACR is null and void pertaining to my case. I was neither on probation/parole or involved in a revocation hearing. Therefore, making my notice of appeal in a timely fashion.

isolation (lockup pending) cell for (9) nine
consecutive days. I was able to neither make a
phone call, access their kiosk (computer) or contact
my attorney until after (10) ten p.m. on July 30,
2021. At this time I sent my request for appeal
or notice of to my attorney, via the kiosk.
I was denied the ability to appeal until that
time.

I apologise for use of pencil and for

Reception and Evaluation, under quarantine.

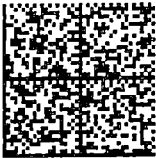
