Appellant, Terence L. Rush, hereby submits this motion Requesting
Permission to Order Transcripts outside of the filing deadlines from the Court
Reporter of the Court of Common Pleas in Newberry County and states the
reasons for this request as follows:

1. The Appellant was never afforded any type of hearing in this action and was unaware that any transcripts may exist.
2. The Appellant was informed that the proceedings could not be held ex parte and would be by brief only to Chief Judge Donald B. Hocker.
3. The Appellant respectfully declare that he is held in the custody of a foreign state to South Carolina who do not hold any of South Carolina's Rules of Court, Procedures, laws or Constitution.
4. The Appellant has been in this disadvantaged position ever since his arrest by Newberry County Sheriff Sergeant Michael B. Stribble, on October 2nd, 2015.
5. The Appellant does not possess computer internet access to make himself aware of South Carolina's Rules of Court, Appellate or otherwise.
6. The Appellant wrote the South Carolina Bar to purchase the required and needed books containing South Carolina's Rules, Procedure and Laws and was never responded to.


