**PETITION TO ENLARGE TIME TO
ORDER HEARING TRANSCRIPT**

Pursuant to Rule 240 of the South Carolina Appellate Court Reports, the Appellants, Maria Shonte' Creel Jordan and Joel B. Jordan, do hereby petition this Court for an Order enlarging the time frame for Appellants to order the hearing transcript for the hearing held on March 9, 2021 in this matter. The Appellants are and have been in possession of the hearing transcript from the initial hearing held on March 3, 2020 in this case. This Petitioner would assert that he inadvertently miscalculated the due date for the Appellants to order the second hearing transcript. It appears that the correct deadline for the ordering of the transcript or to request an extension was September 3, 2021. 
