Ms. Abbott Kitchings,

I mailed the enclosed twenty three (23) page letter, technically a three page letter dated 17 September and 20 pages of exhibits, last week. However, I have recently become worried that I may not have gotten the address correct so I am mailing it again to ensure it is timely delivered.

As an update to the portion of the letter from 17 September related to my attempts to alleviate as many of these obviously obstructive impediments that my family and I continue to face as is possible, I have not yet received any feedback about the seven month overdue preliminary hearings and related reduction / modification of Haselden's Bail Proceeding Form II Order dated 26 January 2021. However, they technically have until this coming Monday to explain and fully cure that significant improper delay.

I have also raised multiple issues with the Charleston County Magistrate court system this past week related to my alleged trespassing on my own family's property apparently starting just a couple of days after filing this appeal this past 19 January.

For reasons that I'm sure are completely irrational given the past few years, I expect most of this to be properly and legally resolved in the very near future. The resolution of those much delayed issues will hopefully allow us to make some progress understanding the details of Scarborough's 7 January 2021 ex parte hearing and also be able to get a copy of that transcript, assuming Ms. Kohn's organization still hasn't been able to get that transcript either, without me getting thrown back into the Sheriff Al Cannon (Esq.) Detention Center.

Obviously the State of South Carolina's Judicial Corruption problem is not confined to the 14th Circuits, but appears to also have a fairly substantial foothold in the 9th Circuit as well as within walking distance of the State Capital. Hopefully Chief Keel's dedication to "*following the facts no matter where they lead*", as he has stated about the still unfolding Murdaugh fiasco, also holds true about all other cases of judicial corruption, including but not limited to, ones in his own backyard. On the off chance Chief Keel isn't quite as dedicated to following the facts about judicial / public corruption issues in Columbia, please note that some of these issues have already been reported to numerous of Chief Keel's Federal partners as well. Consequently, please ensure everyone in your office, all of the Court of Appeals judges, and their law clerks are made aware of this situation as soon as is possible. I feel confident no one wants to apparently mistakenly delete or destroy any possible evidence.

I will also be filing a motion with you next week more specifically addressing several of these issues. In the mean time, please ensure all attorney and party names related to this appeal are correct. Remember Trotter's letter from the end of January?

Ms. Abbott Kitchings,

For ease of reference, I have included the majority of the motion to remand I mailed on 16 July 2021 (14 pages) and the majority of the letter motion I mailed just a couple of days ago to Charleston County about an extremely delayed preliminary hearing (6 pages).

Given how prompt the court of appeals has been previously to dismiss cases related to various and sundry apparent issues, and the strong rationale I included in the motion to remand I mailed two-months ago now, I expected a fairly quick approval of that motion, certainly within the first month after it was received, which I believe was most likely on 19 July 2021. Given another month has passed, and I still haven't received any feedback on this issue, I am following back up on that request.

As is pretty obvious from the 16 July 2021 motion and Haselden's Bail Proceeding Form II Order dated 26 January 2021 (included as an attachment) I can't contact Scarborough, Smith or anyone else related to the "Master and Equity Office" (current and previous) via verbal, electronic, phone, social media, third parties or in writing without getting thrown back into the Sheriff Al Cannon (Esq.) Detention Center...which would obviously make it extremely difficult for me to do anything other than sit in a jail cell for 20 hours a day, including but not limited to, dealing with this very important appeal and other such pending or contemplated litigation. Speaking of which, when you reply could you also confirm that you have already filed a full accounting of all payments I have made to the SC Court of Appeals since December 2017 with the Richland County Clerk of Court, case number 2020-CP-40-06054. Obviously with me not being able to go within a five (5) mile radius of my family's home (also Haselden's Bail Proceeding Form II Order dated 26 January 2021) I can't very readily get to all of my records which are there to do that myself.

To demonstrate I am trying to alleviate as many of these obviously obstructive impediments myself, please refer to the six page letter motion I included dated 15 September 2021. (note that I did not include

Haselden's Bail Proceeding Form II Order dated 26 Jan 2021 in this version being sent to the Court of Appeals since it is included in the 22 Feb 2021 letter I included with the motion) Please specifically note that I requested, in addition to the six plus month improperly delayed scheduling of a preliminary hearing, to have all of Charleston County Haselden's improper restrictions included in the "Other Conditions" section of Haselden's Bail Proceeding Form II Order either significantly reduced or removed altogether. Assuming this is properly acted on within the near future, then I may be able to do something about this ex parte hearing of 7 January 2021, and the associated transcript, which I obviously haven't been able to do to date without getting thrown back into the Sheriff Al Cannon (Esq.) Detention Center.....

All of these Charleston County Haselden restrictions, which at this point in time can only be construed to be intentionally obstructive of justice, combined with other such obstructive overt actions, including but not limited to Maite Murphy's / Auto Owners Insurance Company / Troy Thames "ORDER ENJOINING THE PLAINTIFF FROM RE-FILING THIS MATTER AND IMPOSING SANCTIONS UPON THE PLAINTIFF", can only be construed to be coordinated and with a common a substantial improper purpose.

Please let me know soonest what the issue is with getting these cases remanded back to Charleston County to promptly and fully deal with the ex parte hearing of 7 Jan 2021, which is obviously much more important now that I have found Chief Justice Beatty's 6 May 2020 Order entitled *Certification of Compliance with the Coronavirus Aid, Relief, and Economic Security Act in Evictions and Foreclosure Forms*. Obviously since McCabe, Trotter, Cedar Management, Churchill Park, Churchill Park Homeowners' Association, Inc., etc. has failed to ever file that required certificate of compliance, legally this whole ordeal terminated back on 20 August 2020, if not earlier.

Hopefully by the time these cases are remanded back to Charleston County, Haselden's "Other Conditions" will have finally been resolved and not only can I order the transcript from whoever has it, I can also go to the Charleston County Courthouse and the Federal Courthouse in Charleston without violating Haselden's Bail Proceeding Form II Order and getting thrown back into the Sheriff Al Cannon (Esq.) Detention Center.

The intent of this second letter is to ensure all copied are on notice that I still have not received any type of notice of a preliminary hearing being scheduled in these matters.

It is my understanding that a preliminary hearing in these matters should have been scheduled no later than the end of February 2021, over six and a half months ago. If correct, which I believe is the case, I would have expected to have had such preliminary hearing held no later than the end of March 2021, over five and a half months ago.

Given this ongoing situation, please ensure the preliminary hearing requested in mid February is promptly scheduled within the next ten days, effectively no later than 29 September 2021.

Also, please accept this letter as a request to:

1. Reduce the excessive bail amounts in these matters to the average amount for such charges in Charleston County. Based on my analysis, the bails set for me were approximately four to five times higher than the average required in Charleston County. (eg. \$65,440 should be no more than \$15,440, and likely less, with personal recognizance or case percentage in lieu of bond also being much more rational)
2. Remove the requirement for the GPS monitor. The rationale for this requirement was highly dubious on 26 January 2021, and has only become more suspicious in the last almost eight months.
3. Remove all restrictions which prevent me from attending court hearings in Charleston County without breaking the "Other Conditions" and being thrown back into Sheriff Cannon's jail.
4. Remove any and all other restrictions which cannot be rationally justified. Arguably all listed in the "Other Conditions" section.

Thank you for your prompt attention to these ongoing issues.



AFFIDAVIT

Personally appeared before me, a magistrate of this County, one K. Guth, who, first being duly sworn, deposes and says that

Alan Gregory Nix

did within this County and State on or about the 22nd day of January 2021 violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE
Opposing law enforcement officer serving process
16-9-320

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:


That on January 22, 2021, while at 1401 Densmore Circle, Mt. Pleasant S.C., in the County and State aforesaid, the above named defendant, **Alan Gregory Nix**, did commit the offense of violation section 16-9-340 of the South Carolina State Code of Laws, 1976 as amended, **Opposing law enforcement officer serving process**, in that he did willfully and unlawfully, opposed law enforcement officers attempting to serve a legal writ. The defendant provided written communications to the Charleston County Sheriff's office that he was not vacating his residence at 12pm on January 2021, as he was ordered to do so. A Writ of Assistance (2017CP1004031) stating the same was signed by Judge Scarborough on December 30, 2020 and posted to the defendant's residence on January 11, 2021.


That on January 22, 2021, at 09:37 the defendant sent an email to the Charleston County Sheriff's Office stating "I haven't packed a single thing to move". As well as the statement "I have prepared to defend my family's property" This email also included a list of items entitled "rules of engagement today". At 12:06 pm, Sgt. Craven spoke to the defendant's daughter who advised that her father had not left the residence nor was he planning on leaving on his own. At 16:48hrs on January 22, 2021, the defendant sent another email to members of the Charleston County Sheriff's Office asking for an "accurate schedule of the stated intent to forcibly remove me from my home" He continues on further stating "I've been sitting here waiting for such actions for 4.75 hours" Members of the Charleston County Sheriff's Office were also conducting surveillance of the residence, prior to and after 12pm, and confirmed that the defendant had not left as ordered. On January 23, 2021, at 15:45hrs, the defendant sent another email advising "I've been barricaded in my family's home now for 28 hours, waiting for the assault by the Charleston County Sheriff's Dept. / Charleston County SWAT team that was supposed to happen 27.5 hours ago."

The above information was revealed through the investigation of Sgt. C. Craven and M/Dep. J. Booker, who are witnesses to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

**APPELLANTS' MOTION TO REMAND CASE TO CHARLESTON COUNTY CIRCUIT
COURT TO SORT OUT, WITH FINALITY, THE ONGOING TRANSCRIPT ISSUE
FROM SCARBOROUGH'S EX PARTE HEARING OF 7 JANUARY 2021**

BACKGROUND AND ARGUMENT

Since Appellant Alan Nix couldn't file any SCRCF Rule 59 motions related to these Orders due to Murphy's still obviously improper and misleading Order entitled ORDER ENJOINING THE PLAINTIFF FROM RE_FILING THIS MATTER AND IMPOSING SANCTIONS UPON THE PLAINTIFF (case 2018-CP-10-03315), Appellant Alan Nix just went ahead and filed this additional appeal of Scarborough's Orders filed 31 December 2020 and 8 January 2021 on 19 January 2021. Both orders are again included as exhibits in this motion.

Six days later on the evening of 25 January 2021, Appellant Alan Nix was arrested by the Charleston County Sheriff's Office (in rather grand fashion I might add) at the Sam's Club gas pumps in the Tanger Shopping Center of North Charleston, SC; primarily for allegedly intimidating the victim and witness identified as one Joe Dawson, "*who is an attorney that represents the County of Charleston*". (See affidavits dated 21 and 22 January 2021). The next afternoon, 26 January 2021, Magistrate Haselden issued the attached BAIL PROCEEDING FORM II Order and Appellant Alan Nix remained involuntarily incarcerated in the Sheriff Al Cannon (Esq.) Detention Center for the next fourteen days. After Appellant Alan Nix was finally able to check out of the Sheriff Al Cannon (Esq.) Detention Center late afternoon on 9 February 2021, and subsequently somewhat recovered from his much less than pleasant two plus week stay at the Sheriff Al Cannon (Esq.) Detention Center, Appellant Alan Nix ordered the transcript for the *ex parte* hearing of 7 January 2021 from SC Court Administration by way of letter dated 22 February 2021. (Included as exhibit) To clarify, given Appellant Alan Nix was not at the *ex parte* hearing of 7 January 2021 and had just involuntarily spent over two weeks of less than pleasant time at the Sheriff Al Cannon (Esq.) Detention Center, Appellant was of the opinion that he would rather not return to the Sheriff Al Cannon (Esq.) Detention Center anytime in the near future for violating Haselden's BAIL PROCEEDING FORM II Order dated 26 January 2021. Thus, Appellant Alan Nix mailed the Transcript Request Form to Ms. Kohn's organization rather than Scarborough, Smith or any of Haselden's other New Alleged Victims which "*ARE AS FOLLOWS: ENTIRE MASTER AND EQUITY OFFICE (CURRENT AND PREVIOUS) EMPLOYEES*": (Charleston County Magistrate) *LAURA BECK, KATIE BRUNSON, JAN ONEALE HEARN, CINDY YARBOROUGH, CHRISTINE SMITH, MIKELL SCARBOROUGH, MARTI DENNIS, RYAN CONNOR, SPENCER GILL, JUDY DAWKINS,*

HUNTER JAMES, BARNWELL RASWELL, CHARLESTON COUNTY MAGISTRATE TOM LYNN

Next Friday will be five months since Appellant Alan Nix mailed the Transcript Request Order Form to Ms. Kohn's organization for the transcript from Scarborough's ex parte hearing of 7 January 2021. In an attempt to bring resolution to this ongoing issue, Appellant Alan Nix sent letters about this issue in early May and twice more in mid and late June 2021. In the second letter from June 2021, Appellant Alan Nix even referred Court Administration to Ms. Solicitor Scarlet Wilson since it appears logical that Ms. Wilson would have certainly obtained a copy of this important transcript of Scarborough's 7 January 2021 ex parte hearing as part of her investigation of Appellant Alan Nix's alleged 21 January 2021 intimidation of the alleged victim and actual witness Joe Dawson, "who is an attorney that represents the County of Charleston".

Despite these multiple attempts by Appellant Alan Nix, granted more than slightly obstructed by Haselden's BAIL PROCEEDING FORM II Order dated 26 January 2021, Appellant continues to be totally unable to obtain a copy of this required transcript to further these appeals. Of even greater concern at this point in time, and on information and belief, Court Administration has not only also failed to obtain this transcript but Court Administration hasn't even been able to identify the court reporter that was present at Scarborough's ex parte hearing of 7 January 2021. Hence, almost six months later, there continues to be no resolution to this issue and not even a remotely obvious path to bringing final resolution to this seemingly never ending premeditatedly created fiasco.

Given the number of appeals that the SC Court of Appeals has dismissed for transcript issues previously, and this Appellant's fear that this same solution is part of the plan to prevent these appeals from ever gaining any traction well, Appellant believes the only logical solution at this point in time, over six months later, is to return the case back to the Charleston County Circuit Court so all necessary proceedings before a judge with no conflicts of interest and with actual subject matter jurisdiction can be held to hopefully bring proper and final resolution to these long term issues.

In support of this motion, Appellant Alan Nix states that:

1. Appellant was not at the ex parte hearing of 7 January 2021. (Hence, the ex parte description)

2. Appellant Alan Nix didn't receive notice of the ex parte hearing of 7 January 2021.
3. Appellant Alan Nix didn't know about the ex parte hearing of 7 January 2021 until the other witness to Joe Dawson's (*who is an attorney that represents the County of Charleston*) alleged intimidation emailed Appellant the order filed 8 January 2021 on Saturday afternoon, 9 January 2021.
4. Appellant Alan Nix still has no idea what correspondence the court "*received from the Defendant, Alan G. Nix, subsequent to the issuance of the Writ of Assistance*"; no idea how the court received such correspondence, nor the basis the court found all of this still unidentified correspondence to so obviously "*be without merit*".
5. Appellant Alan Nix, despite numerous attempts, hasn't even been able to identify anyone that was at, or is willing to admit that they were at, or knows someone that was at the 7 January 2021 ex parte hearing.

Since Appellant Alan Nix was not at the ex parte hearing of 7 January 2021, and can't contact Scarborough or have any other third party find out any details about Scarborough's ex parte hearing of 7 January 2021 without violating Haselden's BAIL PROCEEDING FORM II Order dated 26 January 2021 and getting thrown back into the Sheriff Al Cannon (Esq.) Detention Center for an untold amount of time, Appellant Alan Nix is completely out of ideas of how to solve this long term process issue unless these cases are returned to the Charleston County Circuit Court for final resolution.

WHEREFORE, Appellants respectfully requests this Court:

1. Grant this request to return these cases to the Charleston County Circuit Court to resolve this ongoing issue of obtaining a verifiably complete and correct transcript of Scarborough's ex parte hearing of 7 January 2021.
2. Place these appeals on hold until the Charleston County Circuit Court holds and properly concludes all necessary proceedings to fully resolve these issues.
3. Proactively deny any motions under Rule 60(a), SCRPC which Scarborough or anyone else may request to amend any Orders, including but not limited to Ms. Armstrong's Order of Reference from November 2014 for case 2014-CP-10-05407.

(Appellants can imagine that Scarborough, his attorney, Charleston County, the new Charleston County Attorney (to clarify, not the previous Charleston County Attorney

that was an alleged intimidation victim and actual witness on 21 January 2021), and/or the SC Insurance Reserve Fund might view this as an opportunity to try to change Ms. Armstrong's November 2014 Order of Reference to something other than *Richland* or a number greater than sixty days)

4. Officially request Chief Keel's new Public Corruption unit to launch an investigation into this multi year fraud, extortion and cover up scheme.
5. Any other and further relief as the Court deems just, prudent and proper.



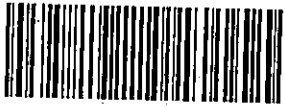
