

TO: THE S.C. COURT OF APPEALS ET. AL.,

THE APPELLANT/PLAINTIFF FILED THE ABOVE CAPTIONED DOCUMENT SEEKING TO RECALL THE REMITTITUR IN THIS CASE DUE TO TIMELY SEEKING WRIT OF CERTIORARI BEFORE THE UNITED STATES SUPREME COURT. THE REMITTITUR SHOULD HAVE NEVER BEEN SENT DOWN IN THIS CASE WHEN JURISDICTION LIED BEFORE THE UNITED STATES SUPREME COURT UNTIL THE SEEKING OF THE WRIT. WAS RULED ON. THE S.C. COURT OF APPEALS ALREADY DETERMINED BY ITS ACTIONS OF RULING ON THIS APPEAL THAT THE CASE FALLS WITHIN THE PARAMETERS OF WAIVING OF FILING FEES DUE TO IT BEING A CHALLENGE OF CONVICTION AND OTHER CONSTITUTIONAL RIGHTS ARGUED WITHIN THE PRIOR PLEADING. 
