Amy, thanks so much for your response. I hope you are well.

I double-checked the information I have and I actually received the 1421297 file on February 8, 2021 and the 1717574 file on February 17, 2021. I asked Chelsea, my paralegal to request any additional documents to make sure nothing had been entered after that date. If there are no additional documents after about February 1, I'm confident I have the entire files.

I did review both files again before responding to this email and did find the statement from Joe Wilson which Ms. Hutchins attached to what was apparently a revised Form 30. I think it's hearsay, it was not before Commissioner Campbell, and is entirely improper as it references what happened at mediation which is privileged, but I will address that with the Court of Appeals. With regard to the other documents, I believe only information that was before the Commission can be considered by the SC Court of Appeals. As a result, what was actually before the Commission is extremely relevant.

In the past where a party to appeal has referenced information which was not before the Commission (such as a Claimant's deposition which was not offered into evidence at a hearing), we have obtained a letter from the judicial director indicating that document was not in the commission's file and attached that as an exhibit to a Motion to Strike any references to the same at the appellate court level. It was my intent to request such a letter in the below email. I don't think the Court of Appeals can rely on my assertion that documents were not before the commission at the time they made their decision. Only a representative of the Commission can speak to that.

Again, my review of both files indicates that none of the documents below are part of the commission's file (except the statement of Joe Wilson). Again, I realize this request is somewhat time intensive, but would greatly appreciate a letter from you or someone else at the commission addressing whether the documents below (excluding the statement of Joe Wilson) are in the Commission's file. If you decline to issue such a letter, I would appreciate a letter to that effect and your explanation so I can share that with the Court of Appeals instead. I want to make sure they are aware I tried to clarify this with the Commission.

Thanks for your attention to this and I truly am sorry to make such an onerous request, but I don't know how else to handle it.

**I am asking you to please reconsider your orders for these motions:**

I was not given a chance to defend myself in these cases. I was lied to by former attorney Thomas Phillips. I have proof of what Thomas Phillips told me that when he sent in the form 50 for case 1717574 that the commissioner signed off on the form 50, that I had to go mediation. Thomas Phillips never responded back to the motions that were filed on May 12, 2020. Thomas Phillips didn't tell me that, I needed to respond back to the motions. Which he was still representing me at the time. He had said he was relieving himself on May 1, 2020, when I voiced that I didn't want to go forward with the settlement reached at mediation. Due to I was still under doctor's care of a physicist and was in no mental shape to be making a legal decision. Which Thomas was made aware of this two days before we went to mediation. I also made the nurse case manager aware that, I was being forced into mediation and I was having panic attacks and anxiety attacks. I had sent in to the commission asking to not rule on these motions until, I was able to defend myself. I wasn't given the chance. I have a witness that was also on a phone call with Thomas Phillips and I. Which Thomas was made aware of, that Joe Wilson was also on the phone. I was still under doctor's care of a Physicist when I was told by Thomas Phillips and also have email's that the form 50 was signed off by a commissioner and it's the law that you have to go to mediation before you can go in front of the commissioner to a hearing. The only reason the form 50 was filed is because, the defense pulled me from the psychologist, I had been seeing since January, 2018. The reason I was going so long was due to ongoing harassment from upper management and co-workers. Because, now I have two work comp cases which is the sexual harassment and assault. Which security finance group didn't give me the chance to tell the whole truth to my story. I also have my knee case with worker's comp. I was then sent to Columbia which was 130 miles one way from my home to an evaluation with forensic physicist. I spent four hours in an evaluation with Dr. Riley forensic physicist, he had all the information from the investigation's. He then sent a report stating what he diagnosed me with and that I needed further treatment. I was then asked by Thomas Phillips if I wanted treatment or if I wanted to settle the case. I told him I wanted and needed treatment. Then I get a letter in the mail saying I have mediation. I called and ask Thomas why I was sent to mediation and he stated that this is the next process. I canceled the mediation that was sent for September of 2019. I was then asked to do a deposition for my Knee case in October of 2019. When I was there I was then asked if I wanted to settle my cases and I said no. I received no


treatment from April of 2019 to January of 2020. I did go back and see Dr. Holland some under my health insurance. Thomas said that the defense should be paying him but they have not. The form 50 was filed for no treatment and mileage and deposition not being paid. Also, while I was going to Dr. Holland he said I needed medicine but, he is only a psychologist and he can't write any prescriptions. So, I had to pay out of pocket for my prescriptions and 20% of co payment to the doctor to get the prescriptions. Thomas Phillips sends a form 50 in on January 12, 2020 and then I get a letter appointment to see a physicist in February 13, 2020. Then in March I receive a letter stating mediation is on April 29,2020. I spoke with Thomas and he tells me the commissioner signed a form stating, I have to go to mediation. I email Thomas asking to send me the paper were the commissioner sign saying that, I have to go to mediation or I can't go in front of a commissioner for a hearing. Thomas sends back the mediation laws and process. I then called him with Joe Wilson on the phone cause I received a mediation agreement. I ask Thomas why would I have to sign this mediation agreement when I don't want to go or want to settle. I am still under care of a doctor and not been placed on MMI. Why would I have to pay for mediation when I am being forced into it. I ask why I would have to sign saying I agree to something when I don't and you are telling me that the commissioner signed saying that I have to go. Thomas the tells Jojo and I that is the law and that, I have to go to this mediation cause the commissioner signed off saying you do. Thomas told me that is part of the mediation process to look up the law on mediation. That you are required to go to mediation before you can go in front of a commissioner at a hearing. I then ask that the mediation paperwork didn't have the right case number that it had my knee claim number on it. Thomas then tells me that it was a mistake by Penny his paralegal. Thomas said mediation is only for the mental claim only. I also have a email were he said that its for the mental claim only. I never signed the mediation agreement. I only seen the physicist Dr. Compean in February 2020, which she agreed with the forensic physicist. I needed more treatment and medication. Dr. Compean also agreed with the diagnose of the forensic physicist of PTSD, general anxiety etc. She started me on medication and treatment. I seen her again in March of 2020, She then changed medication and told me she was leaving to go to another practice that next month would be her last month there. I was then moved to an earlier appointment at the begining of April 2020, where she changed my medication again. Told me she was leaving and that today was her last day. She said they are suppose to be getting another physicist but, didn't know when so she was going to fill my medication for 90 day supply. I told her and the nurse case manager that day that, I was upset. I was being forced into mediation while still under doctor's care and treatment. I texted my nurse case manager Jennifer, on April 26,2020. I was having panic attacks and anxiety attacks due to being forced into this mediation. I needed to see a physicist immediately. She texted back and said they have a psychologist and you can call her but, she hasn't seen you and they don't have a new psychiatrist yet. I then emailed Thomas Phillips on April 27,2020, to let him know that, I was having panic attacks and anxiety attacks and was in no mental shape to go to mediations. Thomas then calls me and I put the phone on speaker so, Joe Wilson could hear what was said. Thomas said he could cancel it but, if you don't go to this mediation then we


can't get in front of a commissioner until we go to mediations. I said well I guess I have no choice but to go. On April 29th, I woke up having panic attacks and anxiety attacks. I went to Tracy Tiddy's office for mediation on April 29th, 2020. Joe Wilson and myself went in along with Thomas Phillips at 9:30 am. Tracy and the mediator Derrick Williams was in a room and He stated that I didn't have to worry about any anxiety today. Derrick Williams explained why we were there for the two cases. I then spoke up and said no sir ,this is only supposed to be about the mental claim and that I was told I had to be here by a commissioner. Tracy spoke up and said I think she is talking about the law that said mediation is a required. Derrick then said oh ok well at some time we can talk about the knee claim. I never said that I would talk about the knee claim. Derrick then said I needed to sign this paper saying this confidential. I looked at the paper and it was the same mediation agreement that Thomas Phillips had sent me. I didn't sign because I didnt agree with it. I then ask Thomas Phillips do I have to sign this because I don't agree with this and plus it has my knee claim on it not my mental claim. Thomas said sign it we will talk about it later. I was not happy about it but felt I had no choice because from my understanding a commissioner had said I had to come to mediation. Tracy left the room and we begin well from my understanding we were only talking about the mental claim. Derrick comes in at 10:30 am with a lunch menu. I stated I was leaving and Derrick kept saying no this isn't over yet sit down let's keep talking. Keep in mind this whole time, I am having anxiety attacks. Joe wilson told Thomas and Derrick that I was in no mental shape right now. Thomas came in from outside with myself after he talked to Derrick and said I told Derrick to tell Tracy to talk about just the mental claim only. I said I thought that is what we were talking about in the first place. I go outside after lunch to my car and Joe wilson was still inside and I am shaking and have a bad headache, my heart was racing and didn't feel good. I texted Joe wilson to let him know I was ready to leave but, he didn't see the text so finally went back into the room and Thomas ask me whats wrong and I tell him. This mediation continues back and forth and I keep saying I want to leave and they kept saying this isn't over yet. I felt I had no choice in leaving due to stress and anxiety. I was very confused and the doctor had just changed my medications. It's about 5:00 pm now and we are still in this mediation when I tell Thomas that I don't like making a split second decision under stress when I can't even think straight. Thomas then ask if I was ready to call it a day and I told him yes. Thomas then said I have to tell you that we are leaving good money on the tablet. Tracy had also talked about the doctor who was going to do my knee surgery and wanted me to drive all the way to columbia to see a knee doctor. So Thomas then goes into the room with Tracy and Derrick and talk. Thomas then comes back to me saying there are some doctor's in Rockhill that they will send you to if you do this settlement. At this time I was so stressed and felt so pressured that I was trapped and couldn't get out of this situation without me signing my name. Derrick has me sign something then he leaves. Thomas and Tracy then types up the agreement and Thomas goes over it and I ask questions and Thomas said that's just what it has to say. Then Thomas has me sign a form 19, I think cause I didn't even remember signing this. The very next day I called Thomas and sent email stating, I was revoking my agreement with Security Group for release of liabilities. I had

seven days to revoke it. Thomas said if I did that the Hartford may not honor the agreement we made yesterday. I woke up in a panic attack the next day of mediation. Then on May 1st at 8:30am which was only 38 hours after mediation. I emailed both Tracy and Thomas to let them know that, I didn't want to go forward with this agreement due to I was in no mental state to be making a legal decision. I needed to see a doctor because I was having a nervous breakdown over this. Thomas called me and Joe Wilson was on the phone, Thomas said he was relieving himself based on the email sent this morning. I then email Thomas if I needed to let worker's comp know. Thomas finally emailed saying to send worker's comp and email stating, I am withdraw from the settlement. Which I did and have emails were I sent to workers comp. I even called Derrick Williams and he said all he does is send in a form 70. Which by the way is incorrect. My name is spelled wrong and he put, we settled on open medical with the left knee. That is incorrect it's the right knee. The form 70 is the only thing worker's comp ever received before, I made them aware of the situation. I revoked my agreement with Security Group. I have proof of all this. I also have a witness to everything that was said. Amy Bracey said that the settlements could not be processed due to my reputation. So, Tracy sent in the motions to compel and a form 21 were she stopped my checks on May 12, 2020. Thomas Phillips had sent in to relieve himself on May 6th, May 12, and then again on May 15, 2020. Thomas Phillips sent me the motions but, never responded back to them nor did he tell me I needed to. Thomas was still representing me at that time. I wrote letters to worker's comp asking time to find a new lawyer and not to rule on the motion until, I was unable to show my evidence. To tell my side of the story. My question is, I was still under doctor's care and was forced into mediation by my former lawyer who told me that a commissioner had signed off saying. I had to go to mediation. Tracy is saying that because both parties were represented at mediation then it's final. I was misrepresented by my lawyer who forced me to mediation while still under a physician. I have also filed a complaint with Office of Disciplinary Counsel on Thomas Phillips. I was lied to by my former lawyer and forced into mediation while still under a doctor and still in treatment. I would have never went to mediation cause, I knew, I was in no mental state to be making a legal decision. The only thing worker's comp ever received was the form 70, which was incorrect. I have proof, I was lied to and have a doctor's note saying that, I was in no mental state to be making a legal decision. I please ask you to reconsider your orders on these motions. My knee motion is that I have waited on the defense for 11 months now almost a year for them to find a new doctor. How much is a reasonable amount of time to find a doctor. I am in pain everyday and can barely walk. The defense has delayed treatment and now delaying hardware surgery that the previous doctor plus 3 other doctor's say I need. This whole process has been a night mare to deal with.
