**Arguments frequently begin before the time set. Please ARRIVE 15 MINUTES prior to your scheduled argument time.**

In recognition of the threat posed by the COVID-19 pandemic, we ask counsel to be mindful of the following policies and precautions:

1. Only the lawyers arguing the case will be permitted to attend oral argument. All other persons may view the oral argument via the virtual courtroom, which is accessible at <https://scjudicial.webex.com/scjudicial/onstage/g.php?MTID=eb51ad70110.21ff736d1c8051d8718920>.
2. Face coverings are required at all times while in the Courthouse. You may remove your mask only when at the podium making arguments before the Court.
3. Counsel entering the Courthouse will be screened for COVID-19 symptoms. You will not be permitted into the building if you are experiencing symptoms associated with COVID-19 or if you have tested positive for COVID-19 within the past ten days. If you are experiencing symptoms or have tested positive within the past ten days, contact the Clerk's office for further guidance.

4. Please maintain social distancing, defined as keeping a distance of at least 6 feet from others, at all times while in the Courthouse.
5. Counsel will be asked to take a seat upon entering the courtroom. Please stay in your seat until you are called to argue. We understand the need to exchange pleasantries, but ask that you keep your seat and remain masked when speaking with others.
6. Hand sanitizer is available in the courtroom, and we ask that counsel use it liberally as you enter or leave the courtroom and/or restrooms.
7. If you arrive before the argument before yours has ended, please wait in Courtroom II until your case is called, while maintaining social distance. Upon conclusion of your argument, please exit the Courthouse as expeditiously as possible. Do not gather to talk until you have left the building.


