I am writing out of concern of ineffective counsel and negligent on the part of my court-appointed counsel James K. Falk of Falk Law Firm, P. O. Box 1058, Charleston, SC 29402.

I, the Respondent, Kevin L. Wright, submits the following based upon information and facts:

1. Around of about July of 2020, Dr. Christopher Gillen, Ph.D., of the South Carolina Department of Mental Health completed an annual review report with the conclusion that my mental abnormality or personality disorder had not so change that I will be safe to be at large.
2. Around or about August of 2020, Dr. E. Selman Watson, Ph.D., was able to complete an Independent Psychiatric Evaluation report with the conclusion that my mental abnormality or personality disorder had so change that I will be safe to be at large. A copy of Dr. Watson report was submitted to the Courts in Charleston County and to the Attorney General Office.
3. On or around October 2, 2020, an annual review hearing was held via video/WebEx before the Honorable Jennifer B. McCoy. Mrs. Deborah R. J. Shupe, Senior Assistant Deputy Attorney

General appeared on the behalf of the state and Mr. James K. Falk appeared on my behalf (the Appellant's). Dr. Gillen was the state's only witness and DR. Watson was the Appellant's only witness.

4. On or around October 28, 2020, Judge McCoy entered an order finding the Appellant failed to meet his burden of proof and that probable cause did not exist.
5. On or around January of 2021, Mr. Falk filed a motion with the Court of Appeals asking for counsel to be appointed to represent the Appellant with his appeal. Mr. Falk also sent the Appellant a letter saying that he anticipate that the Court of Appeals will appoint him to represent me with this appeal.
6. I have not heard anything in reference to this appeal from Mr. Falk since receiving the about letter in January of 2021. I do not even know if the Initial Brief for my Appeal was filed or not.

Can you please assist me in finding out about my Appeal?

Thank you in advance for your time and attention in this important matter

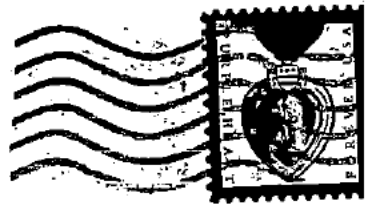
