Appellant's Statement of Facts

On April 26, 2021, the defendant entered pleas in Fairfield County General Sessions Court to the above referenced indictments with Judge Eugene Griffith accepting the pleas. The plea negotiations including a delayed sentencing with the defendant required to return to court for sentencing on June 21, 2021. If defendant abided by the conditions of the plea he would receive a sentence of 10 years suspended to the service of 5 years and 5 years of probation.

The defendant failed to appear at court on June 21, 2021 and was subsequently arrested on several charges of breaking into motor vehicles in Sumter County. He ultimately pled to the charges in Sumter County and was sentenced to 5 years in the South Carolina Department of Corrections.


The defendant was transported to Fairfield County General Sessions Court on October 12, 2021 and sentenced by Judge Brian Gibbons. The defendant objected to the sentencing by Judge Gibbons as Judge Griffith was the plea judge and believed the plea judge had retained jurisdiction. Judge Gibbons overruled the defendant's objection and imposed sentence.

Issues on Appeal

Subsequent to his guilty plea, the defendant requested her counsel to file an appeal regarding this plea. Pursuant to Rule 203(b)(2) and(d) SCACR, defendant's counsel is filing this appeal.

However, after a review of the facts of this case and guilty plea, defendant's counsel finds there is no issue for appeal and believes it to be without merit.
