

TRAFFICKING IN METHAMPHETAMINE  
§ 44-53-0375(C)(1)(a)

At a Court of General Sessions, convened on September 13, 2021, the Grand Jurors of Aiken County present upon their oath:

That **STEVE ALLEN MORRIS** did in Aiken County on or about May 1, 2020, knowingly sell, manufacture, cultivate, deliver, purchase or bring into this State, or did provide financial assistance or did otherwise aid, abet, attempt, or conspire to sell, manufacture, cultivate, deliver, purchase or bring into this State, or did knowingly, actually, or constructively possess, or did knowingly attempt to become in actual or constructive possession of at least 10 grams but less than 28 grams of Methamphetamine, a controlled substance under provisions of Section 44-53-110, et. seq., Code of Laws of South Carolina (1976), as amended, such possession not having been authorized by law.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
