Dear Ms. Kitchings:

I am in receipt of a copy of Attorney for Respondents' Motion for Costs dated October 27, 2021 and I hereby dispute all those requested costs that may be taxable, particularly attorney's fee provided by Rule 222(b) SCACR.

Firstly, Appellant's total costs for printing his Final Brief including all labor, all copies, binders and postage was \$25; 16 pages including 2 cardstock cover pages x 16 copies totalling 256 copies x .05 = \$12.80 + tax, 25 3/8" Fellows 3/8" plastic coil binders = \$5 and \$7 for postage. Enclosed is a copy of the actual invoice from The UPS Store

for 1,238 total copies for Appellant's Brief which totalled \$61.25, for all labor, all copies and all cardstocks.

Appellant's Final Brief totalled 16 pages including 2 cover pages, representing more total copies than Respondent attorney's 13 pages including his signature page and 2 cover pages. Respondent attorney's request that \$244.31 to be taxed to Appellant is excessive and arguable. There is no way on God's Earth that Respondent attorney's costs for printing and mailing his Final Brief could be greater than Appellant's total cost of \$25. Appellant asks the Court to adjust any tax accordingly.

Secondly, Respondent attorney's Final Brief was only 13 pages, including 2 cover pages and his signature page. The total scope of his work was less than that of Appellants. Appellant spent one hour transferring information from his Brief

which was already on his computer, to his
Final Brief, information was not changed.

Respondent attorney's request of a \$2,500
attorney fee for the scope of his work is
excessive and arguable. Appellant requests
the Court to adjust any tax accordingly.
