

I am happy to report that the parties attended mediation on this case (and "this" case is actually four separate actions, of which the current matter is but one) on October 11th, and we have reached a tentative settlement of all issues raised by all four cases, including this one. However, because there are ten beneficiaries and six lawyers, the settlement agreement has been distributed and edited several times since then. I am cautiously optimistic that we will have the settlement paperwork properly signed and filed by all parties in the near future.
