

**NOTICE OF APPEAL**

Kenneth Terrelle Gregg appeals his convictions and sentences for Burglary (Violent)- Second Degree, Kidnapping and Assault and Battery of a High and Aggravated Nature. The sentences were imposed by the Honorable Maite Murphy on October 27, 2021. The Petitioner submits that his plea was not knowingly and voluntarily made because he entered his plea based on false or misleading information regarding a weapon being pointed at the victim by the Petitioner and there was unfair pressure to enter the plea which was not of his own free will. The court also failed to ascertain a factual basis for Petitioner's role in the crimes.
