

**MOTION TO REINSTATE**

I Charles Williams, SCDC #086721, motion the court to reinstate Appellant Case No. 2021-001145. On September 9, 2021, the Appellant received a copy of the honorable S. Phillip Lenski's order dated September 2, 2021. On September 30, 2021, the Appellant filed a Notice of Appeal and a Proof of Service on Matthew C. Buchanan, General Counsel, S.C. Dept. of Probation, Parole, and Pardon Services, and on the Administrative Law Judge, S. Phillip Lenski. On the Proof of Service served on Matthew C. 


