This letter supplements the letter I sent you earlier this week regarding the entity Wall Conway, which is presently captioned in this appeal as a respondent.

Wall Conway was dismissed as a party in this case by way of an agreed stipulation of dismissal. The stipulation was filed in June of 2011 and is attached for your reference. I included Wall Conway as a party in the notice of appeal because the circuit court's final order listed them as a party, but because Wall Conway has been dismissed from the case, its inclusion in the final order can only be a clerical error. 
