**Respondent's Timely Appeal from the Court of Appeals' Refusal to Rehear Single Judge McDonald's Denial of Respondent's Motion to Relieve Counsel because that Denial Has the Effect of Realistically Disposing of This Case; OR, IN THE ALTERNATIVE, MOTION FOR DIRECT HEARING OR APPOINTMENT OF COUNSEL TO ARGUE AGAINST PRECEDENT on the issues of Unappealability and City's non-sovereignty.**

Denial of Dr. Assa'ad-Faltas' basic human right to speak for herself is the issue and is "too important to be denied review until the whole case is adjudicated." And Dr. Assa'ad-Faltas' further statistical studies from C-Track and various SC Counties' Public Indices alone prove that PCR adjudications are unmanageable and grind the wrongly-convicted while lawyers and judges slowly argue, in the words of SC Associate Justice James in oral argument of *Elders v. SC* (DIGed on 21 October 2021), "how many prosecutors can dance on the head of a pin." There appears to be NO UNDERSTANDING that, just as "an invalid law is no law at all," (*Norton v. Shelby County*, 118 US 425, 442 (1886). Also, *Bond v. U.S.*, 564 U.S. 211, 226-8 (2011), Justice Ginsburg concurring with a unanimous Court; and *U.S. v. Davis*, 588 U.S. \_\_ (2019)) a conviction found in PCR to have been unconstitutionally obtained is NO conviction AT ALL; and PCR grantees stand presumed innocent and endowed with *inter alia* rights to speedy retrial.

There also appears total oblivion by this Court (which licenses all those incompetent defense lawyers and opportunistic prosecutors and unleashes them on the public) of its duty to organize the results of all those PCR cases into frequently recurring errors and take effective measures against their further recurrences.

In brief procedural history, Dr. Assa'ad-Faltas *pro se* won her subject PCR twice after it had remained basically unheard for six years; yet, she alone is singled out to not speak for herself as a respondent before SC's appellate courts which heard, e.g., a DISBARRED Kathleen P. Jennings/NKA Kathleen J. Gresham advocate *pro se* unencumbered in all postures in all SC courts (Exx 23-26 before SC's Court of Appeals ["SC CoA"]). Dr. Assa'ad-Faltas is still forced, even as a respondent, to have lawyers, one of whom (Mark Schnee) is also now disbarred. The exhibits hereto are numbered *seriatim* to those submitted to SC CoA.

Dr. Assa'ad-Faltas recently computed that at least (16 + 5 + 2 + 1 + 2 + 1 + 3 + 1 = 31 [highlit in blue]) SC PCR appeals of the 400 SC PCR appeals currently open are allowed to be advocated *pro se* by the losing applicant below. And (1 + 2 + 6 + 5 + 2 + 2 + 3 + 3 = 24 [highlit in gold]) of that set of 400 are appeals by SC's Attorney General ("SCAG") from PCR grants by the circuit court or from SC CoA's reversals of denials of PCR by the circuit court. Dr. Assa'ad-Faltas submits, and wants to argue (preferably *pro se* but by counsel appointed for that purpose alone if this Court insists on counsel) that PCR grants and SC CoA reversals of PCR denials should be unappealable on grounds of principles and practicality.

Also (1 + 1 + 3 + 9 + 14 + 9 + 14 + 1 = 52 [highlit in red hues]) conflicts appear in that 400 set, including in Dr. Assa'ad-Faltas' own case, from the participation of former-SCAG, now-SC-CoA staff, lawyers Lindsey McCallister (Strickland?) and Will Schumacher as quasi-judges of their own cases.

Dr. Assa'ad-Faltas' preliminary search criteria under-captured both the total number of PCR appeals and the number of losing PCR applicants allowed to appeal *pro se*. Some PCR appeals may have been designated "[Applicant] v. South Carolina or v. Warden" and were not captured in a "v. State" search.

Also, *pro se* PCR appeals tend to be dismissed early and are under-represented in *still-open* cases.

The above numbers, undercounted as they are, still prove that SC Appellate courts do not, and never had, a consistently-applied rule against *pro se* PCR appeals. Nor is there any history of Dr. Assa'ad-Faltas filing an abusive or frivolous PCR appeal since **she never initiated a PCR appeal because she had, thank God, won her only two PCR cases adjudicated to finality so far by the circuit court.**

Dr. Assa'ad-Faltas has a moral duty to give members of this Court a chance to do what the U.S. Supreme Court ("SCOTUS") did in in *Trump v. Hawaii*, [No. 17-965](#) 582 U.S. \_\_, slip op. at 38, 138 S. Ct. 2392, at 2423 (2018):

**The dissent's reference to *Korematsu*, however, affords this Court the opportunity to make express what is already obvious: *Korematsu* was gravely wrong the day it was decided, has been overruled in the court of history, and—to be clear—"has no place in law under the Constitution." 323 U. S., at 248 (Jackson, J., dissenting)**

Like SCOTUS' *Korematsu* and *Hirabayashi* decisions, History will view this Court's singling Dr. Assa'ad-Faltas out for mistreatment not meted out on even the worst SC murder convicts (*e.g.*; Barnes and Samuel) for what it was: **naked tyranny against an insular but guiltless member of an identifiable ethnic group.**

This Court held against Dr. Assa'ad-Faltas her request for *symbolic* support of Coptic Orthodox Christians against the horrifying terroristic violence inflicted on their churches. That request stands on the same moral ground as a hypothetical November 1938 SC advocate seeking a *symbolic* statement from this Court against Kristallnacht. This Court's response to Dr. Assa'ad-Faltas leaves no doubt about what this Court's response to Kristallnacht was or would have been if alerted to it. But again, Dr. Assa'ad-Faltas has a moral duty to keep reminding this Court of its past moral failings and to keep asking it to do better.

Further, this Court found matters related to Dr. Assa'ad-Faltas important enough to grant original jurisdiction *when brought by the very Ms. McCallister who now sits as a quasi-judge on Dr. Assa'ad-Faltas in SC CoA*. At least for consistency, this Court should find this important enough to be heard by this Court.

**Wherefore**, this Court should lift the shocking restrictions on Dr. Assa'ad-Faltas' *pro se* appellate advocacy, as such are not placed even on murders or disbarred lawyers; and, in any event, this Court should hear, from Dr. Assa'ad-Faltas speaking for herself or from an advocate on her behalf, why PCR grants and SC CoA reversals of PCR denials should be unappealable and why SCAG lawyers who worked on those very cases as adversaries should not sit as *quasi-judges* (staff counsel) to decide them.
