**APPELLANT'S MOTION REQUESTING PERMISSION
TO SERVE AND FILE HIS INITIAL BRIEF AND
DESIGNATION OF MATTER OUTSIDE FILING
DEADLINES SET BY RULES 208 AND 209 SCACR.**

In response to the Clerk's letter dated November 9, 2021, and received by Appellant on November 15, 2021, the Appellant, Russell Mawyer, moves the Court for permission to serve and file his initial brief and designation of matter outside the filing deadlines set by Rules 208 and 209 of the SCACR. 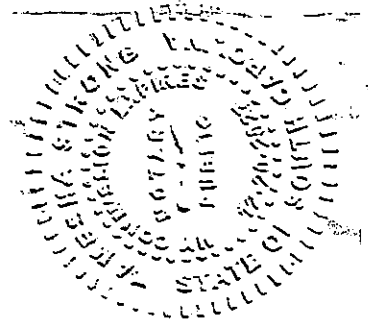


