
Respondents themselves filed: (From Respondents motion)

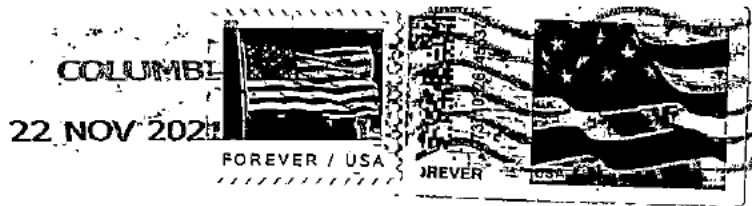
