Appellants' First Motion for Extension of Time


The current deadline is December 9, 2021. With the extension, the new deadline would run through Monday, January 10, 2021.¹

Counsel requests the extension because of numerous other case obligations and conflicting court deadlines. These obligations are preventing him from completing the Initial Brief within the current deadline. The extension is not for the purposes of delay.

¹ Because the last day of the thirty-day period would be a Sunday, the next day "which is neither a Saturday, Sunday nor such holiday" would be Monday, January 10, 2022.

Therefore, for good cause shown, Appellants move the Court to extend the deadline for their Initial Brief through **Monday, January 10, 2022**. Appellants ask that the current deadline be held in abeyance pending the Court's resolution of this motion.


