
Respondent Design Review Board (DRB) of The Town of Sullivans Island (S.I.)  
 (“Respondent”) moves this Court for a thirty (30) day extension of time to file its Initial Brief.  
This is Respondent’s first request for an extension. Respondent states as follows in further support  
of its Motion:

Appellant initiated this appeal on October 3, 2019. After the appeal was dismissed on  
November 17, 2020, Appellant moved to reinstate the appeal which was granted on January 14,  
2021. Appellant failed to timely file her Initial Brief and as a result filed a Motion to allow the  
late filing of her Initial Brief on October 18, 2021. That Motion remains pending.

On November 8, 2021, Appellant filed her Initial Brief, according to the Court of Appeals' case management system. If Appellant's late filing is permitted, Respondent's Initial Brief would be due on December 8, 2021, measuring from the date of filing. 
