**MOTION REQUESTING PERMISSION  
TO ORDER TRANSCRIPT OUTSIDE OF FILING DEADLINE**

In accordance with the Court’s December 3, 2021 letter, Appellant respectfully moves for permission to order the Circuit Court transcript outside of the Rule 207(a)(1), SCACR, deadline set forth for ordering such transcript. The Rule 207(a)(1) deadline for requesting the transcript expired on November 18, 2021. Counsel for Appellant requests this extension to order the transcript on the grounds that his father passed away on November 14, 2021 and he was out of the office the week the deadline expired. With

respect to the two orders Appellant is appealing, the Circuit Court held a hearing before issuing the first order but not before issuing the second.
