I am in receipt of Respondent's counsel's letter to the court dated December 6, 2021 and the enclosed opinion in Arredondo v. SNH SE Ashley River Tenant, LLC, 433 S.C. 69, 856 S.E.2d 550 (2021), *cert denied* 595 U.S. ___ (Dec. 6, 2021). In response, and pursuant to Rule 208(b)(7), SCACR, Appellants note that the language of the Health Care Power of Attorney considered in Arredondo differs significantly from the language of the Health Care Power of Attorney in the case at bar, and thus the Arredondo decision is neither binding precedent nor instructive to the arguments made by Appellants in this case. This issue pertains to Argument I on pages 5-12 of Appellants' Final Brief, and to Argument I on pages 1-5 of Appellants' Final Reply Brief.
