Ms. Singleton,

We represent one of the 14 subcontractor respondents in the above appeal. There are two Appellants in the matter and one of them, the owner appellant, served its Initial Brief and Designation on December 6; and the second, the general contractor appellant, was granted an extension to serve theirs until January 5, 2022. The Order entered earlier today does not state when the Respondents Initial Brief and Designation are due, and we find nothing in Rule 208 to shed any light on the matter.
