**APPELLANT'S MOTION FOR SECOND EXTENSION OF TIME  
TO FILE/SERVE RETURN TO RESPONDENT'S MOTION  
TO DISMISS THE APPEAL AND COUNTERCLAIMS**

NOW COMES Appellant, Mark dos Santos, by and through his undersigned counsel, pursuant to Rule 240(e), SCACR (“The court may in its discretion enlarge or limit the time for filing the return.”), and Rule 263(b), SCACR (providing that the Court may extend the time prescribed by the South Carolina Appellate Court Rules for performing any act except the time for serving the notice of appeal under Rules 203 and 243, SCACR), and, on the grounds set forth below, hereby moves this Honorable Court for an additional extension of 10 days’ time, i.e., from today, Thursday, December 9, 2021, to Monday, December 20, 2021, to file/serve a return in opposition to Respondent’s Motion to Dismiss the Appeal and Counterclaims (the “Motion to Dismiss”).

Respondent filed/served the Motion to Dismiss on November 15, 2021, making Monday, November 29, 2021, the original deadline for Appellant to file/serve a return thereto. *See* Rule 240(e) (“Any party opposing a motion or petition shall have ten (10) days from the date of service thereof to file . . . his return with the clerk and serve on all parties a copy of the return[.]”); Rule 263(a) (“In computing any period of time prescribed or allowed by these Rules, by order of court, or by any applicable statute, the day of the act, event, or default after which the designated period of time begins to run is not to be included. The last day of the period so computed is to be included, unless it is a Saturday, Sunday or

a state or federal holiday, in which event the period runs until the end of the next day which is neither a Saturday, Sunday nor such holiday.”).

By order filed December 6, 2021, the Court granted Appellant’s motion for an extension of his return deadline to today, December 9, 2021.

Because of work-related and other time commitments, the undersigned requests that the Court extend the time for Appellant to file/serve his return to the ~~Motion to Dismiss by 10 additional days, i.e., from today, Thursday, December 9, 2021, to Monday, December 20, 2021.~~ Most respectfully, the undersigned submits that the grant of such relief is consistent with the interests of justice and will not result in any undue prejudice or delay.

Wherefore, Appellant moves this Honorable Court to grant him an additional extension of 10 days’ time to file/serve his return to the Motion to Dismiss. If the requested extension is granted, the new deadline for Appellant’s return will be Monday, December 20, 2021, according to the undersigned’s calculations. *See* Rule 263(a) (regarding computation of time). Additionally, Appellant asks that the Court hold his return deadline in abeyance until it rules upon this motion.

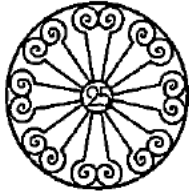

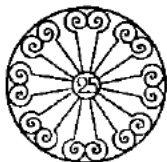
