**NOTICE OF APPEAL**

The State of South Carolina, through the South Carolina Department of Probation, Parole and Pardon Services (SCDPPPS), by its attorney, Matthew C. Buchanan, appeals the order of the Honorable Frank R. Addy, Jr., dated November 29, 2021, dismissing the above-referenced warrants for the violation of probation.

The State further appeals Judge Addy's unfiled November 9, 2021 order in the event that it is *nunc pro tunc* with the November 29, 2021. The court stated in an email to all parties that the Nov. 9 order is not a final order. (See attached).


On November 12, 2021, counsel for SCDPPPS sent an email to all parties stating its intention to file an appeal of the final order and wishing to preserve its rights regarding the

timing of filing the notice of appeal. (Attached). This was acknowledged by the court in a follow-up email on November 12, 2021. (Attached).

As of the date of this Notice of Appeal, the court's final order has not yet been filed. Furthermore, SCDPPPS respectfully requests leave to supplement this Notice of Appeal at such time as a final order is issued by the circuit court.

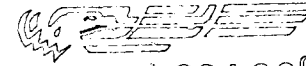
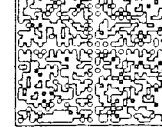
