MOTION FOR EXTENSION OF TIME FOR APPELLANT TO
SERVE AND FILE INITIAL BRIEF AND DESIGNATION OF MATTER TO
BE INCLUDED IN THE RECORD ON APPEAL

Pursuant to Rule 240, SCACR, appellant Paulette Lawrence moves for an extension of time in which to file and serve appellant's Initial Brief and Designation of Matter to be included in the Record on Appeal ("Designation of Matter").
