
**Re: Kevin Staveley-O'Carroll v. Fenix Automotive, LLC

Dear Ms. Kitchings:

I represent the Appellant in the above-referenced appeal of an order of judgment from the circuit court. Prior to filing our notice of appeal on November 17, 2021, we first moved for the lower court to alter, amend, and reconsider the order of judgment. To support the grounds for our Rule 59 motion, on October 15, 2021, I contacted the court reporter and ordered a copy of the transcript she took down of the damages hearing on which the lower court based its order of judgment. *A copy of my October 15, 2021 e-mail request for transcript is enclosed for reference.* However, on November 2, 2021, prior to our receiving the transcript from the court reporter, the lower court denied our Rule 59 motion, without a hearing.

At the time we filed our notice of appeal, we had still not received the transcript.
