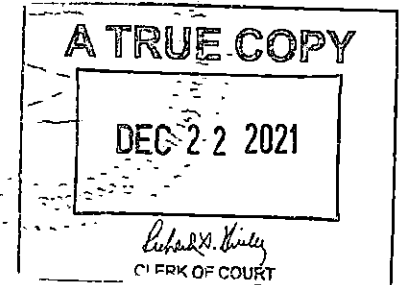
NOTICE OF APPEAL



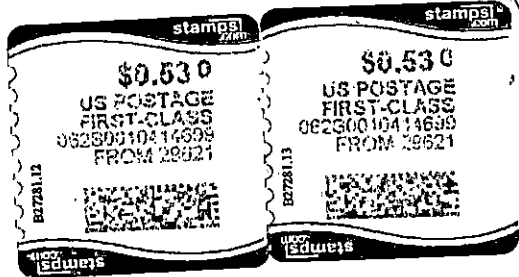
