1. **Appellant Replies to the Return to Appellant's Motion for an order of this Court limiting the Record on Appeal.**
2. **It is telling that Respondent has not stated exactly what additional material they deem essential for the resolution of this matter that would be excluded from the Appellate Panel by allowing the motion as plead.**
3. **In particular Respondent has not stated why it would be for the Appellate Panel's benefit to reproduce many (as many as twelve) and file duplicate copies of exhibits and other documents, nor explained why Respondent's council bloated the material in the docket by filing duplicate copies of the same document as exhibits to the same pleading and why she would have the record include, as one filed item, a copy of all material that came before that date. Reproducing redundant copies of the same document does not give the document any evidential additional weight and the demand to replicate same is simply an abuse of judicial process.**
3. **Respondent has ignored that on May 17, 2012 prior to trial Respondent's Counsel entered into a consent order (Exhibit A to Motion) declaring that all disputes on any matter before that date were resolved.**
4. **No Cross – Appeal has been filed and the only issues before the Court are (a) the conduct of the trial; (b) the post – trial manner in which the Special Referee prepared the final order; (c) the final order, and (d) the preservation of objections related to the preceding three.**
5. **Other than the dismissal of Respondent Counsel herself as a Defendant in the 2009 case, the trial court pointedly made no findings of fact or conclusions of law prior to trial. The motion practice and hearings related to discovery which relate**

largely to Respondent's Counsel failing to meet Defendant's discovery obligations and are appealable – by Appellant. Papers related to discovery will contribute nothing to deciding the issues under appeal.

6. It is also clear that the Special Referee never had possession of any of the other documents that Respondent seeks to include in the Record on Appeal because he never obtained them from the Clerk of Court (Exhibit C to Motion) and the only material the Special Referee actually had available to him were potentially the Trial Exhibits returned to the Clerk of Court on January 23, 2013 (Exhibit B to Motion). None of the pre-trial pleadings were ever before the Special Referee. Respondent has failed to explain how the Final Order could properly depend on pleadings that he did not see, and what he might have learned from these prior documents is hypothetical and not salient to questioning what he did with what he had. The Respondent is simply silent on these relevant considerations.

7. The issue of the Record on Appeal is “ripe”. On April 22, 2013, four days before Respondents' Counsel filed her Return, Appellant served and filed his “Form 14 Designation of the Record on Appeal” (Exhibit A).

8. Case Dockets – what is missing and relevant? Also available to Respondent were the three (3) Dockets of the consolidated cases: (a) 2009-CP-26-3596 (Exhibit B); (b) 2010-CV-26-1072943 (Exhibit C) which is the second case while it was in the Magistrate Court before it was transferred at Respondent's Request; and (c) 2010-CP26-11320 (Exhibit D), the Magistrate Case after transferring it to Circuit Court. The list of all the “other” material was thus available to Respondent when she drafted her Return and it is mysterious as why Respondent did not list at least one


item, as an example, that she felt would be useful and germane to the Appellate Panel. The silence is deafening.

9. The Appellate Panel now has before it the structure of what Appellant feels is relevant (in the form of the motion), the structure populated (in the form of Appellant's "Form 14 Designation of Record", Exhibit A to this Reply), and the enumeration of all potential documents in the cases in the form of the Dockets (Exhibits B, C and D). Given the consent order related to matters prior to trial, the focus of the appeal on the limited and self-contained period from the case's Referral to the Special Referee to after objections to his Order had been filed, it is plain to see that everything which is relevant has been identified in the Designation of Record within the proposed structure.

10. To reiterate from Appellant's Motion, the material relevant to reviewing the conduct of the trial and the formulation and entry of the final order is:

- (a) *The Complaints, Answers, and Replies as amended;*
- (b) *The Trial Exhibits as listed in the Transcript;*
- (c) *Additional Documents set before the judicial officer at trial but not listed as exhibits by the contract court reporter;*
- (d) *The Rule 16 Lists of Exhibits and Witnesses presented to the Court and exchanged by the parties;*
- (e) *The Pre-Trial Deposition Transcripts from the depositions held by Order of Court to be used at trial in lieu of or to supplement trial testimony which were filed with the Clerk of Court for use at trial;*
- (f) *Orders, Pleadings and other documents for the period beginning with the June 13, 2012 Order of Reference (to the Special Referee) and ending with the Special Referee's Order of Recusal dated October 17, 2012, which includes the final order dated September 10, 2012 following the August 8 – 10, 2012 trial before the Special Referee;*
But excluding reproduction of duplicate copies of documents in those categories so that only one copy of any particular document is reproduced.
- (g) *The trial transcript.*

11. I ask for this.




