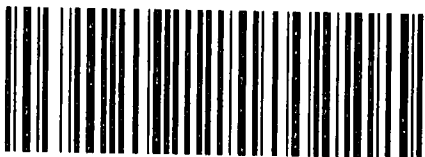

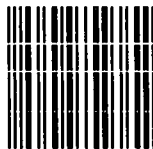

Dear Mrs. Gee,

I believe the Court (South Carolina Court of Appeals) has erred in many ways. I have been treated unethically by the court and the opinion rendered is a gross miscarriage of justice. The Court does not believe that a pro se litigant should be afforded the same courtesy before the Court as a licensed attorney in the state of South Carolina.

"Dear Chuck

,..... Whenever we have an appeal the clerk of the Court of Appeals always calls us the day the decision is announced and tells us the outcome, and then faxes us a copy of the opinion. I thought they would accord you the same courtesy. I don't know the details of your case, but I do know you litigated it with conviction and passion and were certainly convinced of the righteousness of your cause.

The Court filed the opinion on December 5, 2012, as to date I have not received a phone call or a copy of the decision rendered by the Court. I just recently learned of the decision as it is posted on the internet. I am not sure how the Court can justify this as ethical, impartial and fair treatment. Common sense would dictate the fact that I was not about to give up and would have filed an appeal with the South Carolina Supreme Court. I believe in good faith that it was the intention of the Court not to notify me of the decision. Once the time limit of the decision made by the Court expires an appeal cannot be filed with the South Carolina Supreme Court.

Unfortunately due to my ignorance on how to file a complaint in the proper text and format, the Honorable Judge Johns gave me instructions and allowed me 20 days to file an amended complaint. In my original complaint, I had named Joe Wilson as one of the defendants in my original complaint. After careful consideration, I felt that Joe Wilson was a victim of circumstances created by the other defendants named in the original law suit. All documents filed with the lower court and the Court of Appeals by me did not include the name of Joe Wilson. In a letter sent to you from me in reference to Joe Wilson being added to the Appeal. You wrote a letter to defendants' counsel, Mr. James K. Gilliam in reference to Joe Wilson being named as a defendant. Mr. Gilliam advised you that it was not necessary to add the name of Joe Wilson. You then wrote me a letter to instruct me on how to write the caption on the front page of the appeal. The Court has 15 copies of the exact instruction you gave me. The name of Joe Wilson is not in the caption per your instruction. **How and why did the three Court of Appeals Judges concur and feel compelled to add the name of Joe Wilson?**

Once again due to my ignorance according to the Court's decision, I filed the appeal based on the fact that I did not receive a fair and impartial hearing in any proceedings before the lower court. In my brief, I was very explicit and clear on the biased and prejudicial treatment by the lower court. In

documentation presented to the of lower court as exhibits and to the South Carolina Court of Appeals in the Record on Appeal, I proved all of my allegations not only beyond a reasonable doubt, but beyond any doubt whatsoever.

The Court decided (Huff, Thomas and Geathers, JJ., concur) to base the opinion on the most minor issue and failed to give an opinion on the appeal that I did not receive a fair and impartial hearing based on facts in the lower court. How is it possible that the Court could reach a unanimous decision to Affirm the ruling of the not so Honorable Larry B. Hyman Jr.? I have testified in court hundreds of times and heard hundreds of cases presented attorneys providing a rigorous defense on behalf of their clients. Generic only to the South Carolina Judicial System does a presiding judge have the authority and power to grant Henrietta Golding (McNair Law Firm- counsel for the defendants) immunity to knowingly give false testimony before the court and present to the lower court in writing false statements. According to the oath of an officer of the court, this is a violation by statute. I proved this to the court. The lower court was not interested in the truth, only interest of the court to rule in favor of the defendants and Henrietta Golding. It is quite difficult to count the number of times Henrietta Golding lied to the lower court. Mr. James K. Gilliam (McNair Law Firm) followed the steps of Henrietta Golding to the Court of Appeals and the U.S District Court. Mr. Gilliam knowingly in documents presented to both this Court and the U.S District Court. The South Carolina of oath of office only applies to those attorneys who are willing to follow the rules.

I would never recommend Coastal Carolina University as long as any of the defendants named in my appeal are employed by the university. The president of the university (David A. DeCenzo) I have known him since the early 70's. At the time, I was a Maryland State Trooper assigned to the investigation division; Mr. DeCenzo was a Cadet on the Prince George's County Police Department. Mr. DeCenzo is a liar, unethical, corrupt and does not know the meaning of the word integrity. This statement also applies to the other defendants as well as Co-Counsels, Henrietta Golding and James K. Gilliam.

Included with this letter is a copy of an email fabricated by President DeCenzo of which he signed my name to it and was submitted as defendants exhibit in a deposition conducted by Henrietta Golding. The email has been evaluated by too email experts and both agree that is impossible for anyone to send this email in the format in which it has been fabricated. President DeCenzo filed a false report of a crime to the Coastal Carolina Police department accusing me of unlawful communication and making threats against him. The only conversation I had with President DeCenzo was after we met for breakfast at his request. My only other communication with President DeCenzo was thru email thru his personal email address at his request. Mr. DeCenzo advised me thru email correspondence that he wanted to clean up the Department of Public Safety so that it could be certified by CALEA. President DeCenzo advised me thru email correspondence that the corruption and unethical practices, including CCU policy violations of the Department of Public Safety would be investigated by Pat West (Department Head, Human Resources) Timothy Meacham (CCU legal counsel) another lie told by President DeCenzo.

I learned of the false report of a crime to the Coastal Carolina Police Department made by Mr. DeCenzo and false statements' made to the police department by the other defendants' thru discovery. I personally met with Assistant Solicitor Scott Graustein in his office. Mr. Graustein agreed, if I could prove my case a crime had been committed. Mr. Graustein told me that it would be unethical for the Solicitor's office to investigate criminal allegation while there was a pending civil action. Mr. Graustein was unable to explain to my satisfaction as to how this could be considered unethical.

I spoke with Horry County Solicitor Gregg Hembree on the telephone as he declined to meet with me personally. Mr. Hembree agreed that if I could prove my allegations a crime had been committed. Solicitor Hembree's explanation was quite different than that of Mr. Graustein. Solicitor Hembree told me that it would be a waste of tax payer dollars to investigate this crime, because their office had **three thousand** more important crimes to investigate.

I have accumulated over a thousand pages of documentation; including court filings, emails, letters, and an electronic recording to verify all accusations to be true not only beyond a reasonable doubt, but beyond any doubt whatsoever.

A panel of three judges ruled that I received a fair and impartial hearing before the not so Honorable Larry B. Hyman Jr. in the Circuit Court of Horry County. In good faith I believe that it was a kangaroo court and the outcome was pre-determined. I think the following Cliché' is appropriate under the circumstances. **"If we don't tell on each other, no one will know and we won't get in any trouble, but if you tell on me, I will tell on you and we will both get into trouble"**

Governor Nikki Haley during her campaign was animate that the South Carolina Government would be totally transparent with nothing to hide from the citizens if she was elected. Governor Haley was advised in writing of everything included in this letter and supporting documents to prove all of my allegations. I can only assume that transparency was just another broken campaign promise. Ironically, Governor Haley is the Chairman of the Board of Coastal Carolina University. Only one conclusion, Governor Haley is in agreement that the unethical and criminal practices by CCU President David A. DeCenzo and his Teflon coated staff. The only action taken by Governor Haley after learning of my allegations, was to have me terminated from my security position at Broadway at the Beach. I was informed by immediate that the call came from the Governor's office.

The Constitution of the United States, the second amendment guarantees my right to freedom of speech as long as I continue to tell the truth, which is what I will do. I will continue to tell the truth to anyone who is willing to listen and I will continue to write letters to anyone who is willing to read them. The South Carolina Court of Appeals posted on the internet their opinion (Charles R. Machado vs. Coastal Carolina University) of summary judgment in favor of the defendants. It is only fair that I post my opinion on the Internet, (southcarolinawatergate.com) (coastalcarolinacorruption.com) more sites to be added at a later date.
