
Dear Hon. Kitchings;

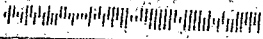
