ORDER DENYING MOTION TO  
RECONSIDER SENTENCE



This matter comes before the Court on Defendant Breante Stevens' motion to reconsider his sentence. A jury trial was held, and Defendant Stevens was found guilty on one count of Voluntary Manslaughter, one count of Assault and Battery of a High and Aggravated Nature, two counts of Possession of a Weapon During the Commission of a Violent Crime, and one count of Possession of a weapon by a person convicted of a crime of violence. Defendant Stevens was sentenced to a total of 50 years in prison on October 29, 2021.

Defendant Stevens timely filed a Motion to Reconsider Sentence on November 2, 2021. A hearing was held in Lancaster County on December 15, 2021. The Court heard oral arguments from both the State and the Defense, as well as further mitigation from the Defendant's family. Overwhelming evidence was introduced by the State in the trial of this matter. While the Defendant was only convicted of the charges above, this nightclub shooting was reckless and in total disregard for human life. Two people died and eight were seriously injured.

Having considered the entire record in this case, the Court respectfully denies Defendant Stevens' Motion to Reconsider Sentence.





