
After careful consideration of the motion and the response in opposition, and in consideration of the prior orders of the Court, the evidence presented, the issues raised, the procedural and substantive arguments raised by the parties, the Court finds no cause to revisit and change its rulings in this matter. The Court reaffirms its findings of facts and conclusions of law, which have been fully considered as required by law. S.C. Code Ann. §17-27-80 (1976); Rule 52(a), SCRCP; *See also McCray v. State*, 305 S.C. 329, 408 S.E.2d 241 (1991). This Court has, in its discretion, considered this matter based upon the motions submitted by the parties, since oral argument will not aid the Court in reaching its decision. *See* Rule 59(f), SCRCP. Applicant's Rule 59(e), SCRCP motion is therefore denied in its entirety.

This Court notes that if Applicant desires to secure appellate review of this order and the final order of dismissal, a notice of appeal must be filed and served within thirty days of the service of this Order. Applicant is directed to Rules 203, 206, 243 of the South Carolina Appellate Court Rules for the appropriate procedures to follow after a notice of appeal has been timely filed.


