FACTS

Pursuant to Rule 208(a)(3) SCRAP, the Appellant may file a Reply Brief to the Initial Brief of the Respondent within ten days after service of the Respondent's Brief; and,

Pursuant to Rule 210(a) SCRAP, the Appellant shall serve the Record on Appeal within 30 days after service of the last brief; and,

The Appellant has filed the Initial Brief by USPS mail on January 14, 2022 so that it is possible that the Respondent's Initial Brief will be due on or about February 17, 2022; and,


