**RESPONDENT'S MOTION FOR COSTS PURSUANT TO RULE 222**

Pursuant to Rules 222 and 240 SCACR, Respondent Genevieve Stratos (Stratos) requests the costs of this appeal be taxed against Appellant Karmatic, LLC. Stratos is entitled to seek and recover costs pursuant to Rule 222(a). Appellant is to be taxed costs when the appeal is dismissed. The appeal was dismissed by agreement with Stratos' right to seek costs preserved as set forth in the Agreement to Dismiss Appeal received and filed with the Court on December 20, 2021. Pursuant to Rule 222(b), the costs allowed Stratos include: (2) the cost of the court reporter's transcript; (3) premiums paid for costs of supersedeas bonds or other bonds obtained to preserve rights pending appeal; and (5) the cost of printing the party's final brief(s) under Rule 210. In addition, the party shall be entitled to recover an attorney's fee in an amount which shall be set by order of the Supreme Court.


