INDICTMENT FOR

DOMESTIC VIOLENCE OF A HIGH AND
AGGRAVATED NATURE
AND
ATTEMPTED MURDER

At a Court of General Sessions, convened on AUGUST 24, 2017 the Grand Jurors of FLORENCE County present upon their oath:

COUNT ONE- DOMESTIC VIOLENCE OF A HIGH AND AGGRAVATED NATURE

CDR: 3814 16-25-0065(A)

That SAMUEL LEE MCNEIL did in Florence County on or about December 8, 2016, cause physical harm or injury or offered or attempted to cause physical harm or injury to his own household member, TANISIA CUNNINGHAM, with apparent present ability under circumstances reasonably creating fear of imminent peril, and under circumstances manifesting extreme indifference to the value of human life causing great bodily injury or which would reasonably cause a person to fear great bodily injury or death to wit: by striking her about her head, face, and body with a glass bottle causing numerous lacerations and injuries, requiring her to seek emergency medical attention, in violation of Section 16-25-0065(A), S.C. Code of Laws, 1976, as amended.

COUNT TWO- ATTEMPTED MURDER

CDR: 3410 16-03-0029

That SAMUEL LEE MCNEIL did in Florence County on or about December 8, 2016, with intent to kill, with malice aforethought, either expressed or implied, attempt to murder one TANISIA CUNNINGHAM, by striking her about her head, face, and body with a glass bottle causing numerous lacerations and injuries, requiring her to seek emergency medical attention, causing great bodily injury and/or substantial risk of death; in violation of Section 16-3-0029, S. C. Code of Laws, 1976, as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
