CONSENT MOTION FOR CONTINUANCE OF ORAL ARGUMENT

COME NOW the above-named Appellants, pursuant to Rules 240 and 263(b), SCACR, and with the consent of counsel for Respondents, moving this Court for an Order continuing oral argument currently scheduled March 8, 2022.

Counsel received the Court's November 9, 2021 notice regarding the potential of oral argument taking place in March 2022. However, in January 2022, having not received Notice of Oral Argument and therefore believing the case had not been chosen for argument in March, counsel for Appellants booked a family vacation from March 7-15, 2022 and obtained protection from court appearances during that time. The Notice of Oral Argument was subsequently received on February 1, 2022.

Under the circumstances, and given the complications wrought by Covid on family vacations over the last two years, counsel for Respondents (Mr. Fred Kuhn) kindly consented to this request. Mr. Kuhn indicated that he does *not* wish to forego oral arguments in favor of a ruling on the briefs, though Appellants would be amenable to such a resolution.


