**PETITION FOR EXTENSION TO FILE

2. Counsel filed the Anders brief of appellant, designation of matter, and record on appeal in the case of State v. Christopher L. Sanders in this Court on January 31, 2022. On January 21, 2022, counsel presented on the topic of Evidence at the 2022 S.C. Bar Convention. Counsel filed the petition for writ of certiorari to the Court of Appeals in the case of State v. Counsel attended a PCR Hearing as a potential witness in the case of State v. Edward Chandler in Lexington County on December 14, 2021. Counsel had an oral argument in the case of The State v. Zantravious Randell Hall with Court of Appeals on December 8, 2021. On December 1, 2021, counsel represented Kinjta Kadeem Sadler at a guilty plea hearing in Greenville. Counsel filed the reply brief of petitioner in the case of State v. Sidney Moorer in the Supreme Court on November 29, 2021. Counsel filed the brief of petitioner and appendix in the case of Robert Lee Wright v. State in this Court on November 29, 2021.

3. This request is made in good faith, and not for purposes of delay.

4. Opposing counsel, for the Attorney General's Office, has graciously consented to this extension request by way of the general consent granted by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through February 28, 2022. That general consent was dated January 31, 2022.

WHEREFORE, the undersigned counsel respectfully requests a thirty-day extension in which to file the initial brief of appellant and designation of matter in this case. Counsel requests that the time limits for filing the initial brief of appellant and designation of matter be held in abeyance pending a ruling on this motion.
